

\And What's next in 2022-2023

- Adding new Instructional Unit reports using the new planned minutes field, as mentioned in prior webinars
 - Have started editing existing course reports to add planned instructional time field
- New CRDC reports for 21-22 OCR submission
 - No dates announced yet by OCR but it is expected to occur in Summer 2023, hopefully after end of year reporting. NDE will attempt to update list of Superintendents with OCR before then.
 - Based on how last year went the new idea is for NDE to offer districts a CRDC format file through ADVISER Validation that can be viewed, exported as a .CSV file, then uploaded by yourself to OCR with no intervention from NDE

New IEP Begin Date

Use: Dashboard X State Reporting CRDC

Resource: /StudentSpecialEducationProgramAssociation/IEPBeginDate Definition: The effective date of the student's current IEP or IFSP. Typically this date changes once per year, and may or may not be the same as the SPED program record Begin Date field.

2.2 Multiple Disability Descriptors

NDE will now require SIS vendors to be able to support sending multiple disability codes within a single SPED program record.

DISABILITY

Use: Dashboard X State Reporting X CRDC Resource: /StudentSpecialEducationProgramAssociation/Disabilities/DisabilityDescriptor No changes to this field

New DISABILITY ORDER

Use: Dashboard X State Reporting X CRDC

Resource: /StudentSpecialEducationProgramAssociation/Disabilities/orderOfDisability Definition: A number indicating the ordering for records where there are multiple disability codes reported. The student's primary disability should be marked as 1, and any additional disabilities reported should be a higher number.

New PART C TO B TRANSITION DELAY REASON

Use: Dashboard X State Reporting X CRDC

Resource: /StudentSpecialEducationProgramAssociation/_ext/Ne/PartCTransitionDelayReasonDescriptor Definition: A reason that a student who has reached their 3rd birthday continues to be served under Part C rather than Part B. This field may be left blank for students where this does not apply.
