Summer 2022 Wrap Up

- All Summer 2022 benefits have been issued
 - Two issuances:
 - December 13, 2022 (Omaha) and December 15, 2022 (Other)
 - March 16, 2023 (All makeup)
- Reconsiderations are still being accepted
- Contact NDE with questions about:
 - Address updates
 - Guardian updates
 - Card status
 - Additional qualifying students

尽 SY2022-2023 P-EBT Plan

- SY22-23 Plan is under review by USDA; NDE portal opens today (4/12) for data uploading
- Benefit level determined by number of COVID-related absence days per month

Tier	# of Absences (per month)	Benefit Amount
1	Less than 6 days	\$35
2	6-16 days	\$82
3	More than 16 days	\$139

尽 SY2022-2023 P-EBT Eligibility

First, school building must be eligible, then students within the building may be eligible.

1. School building eligible when:

- Any student has a five-consecutive day COVID-related absence
 - First day of this absence is the first day other students are eligible
- Based on individual school sites

2. Student is eligible when:

- Qualify for Free or Reduced-priced meals in SY22-23, AND
- Experience COVID-related absence for any number of days

尽 SY2022-2023 P-EBT COVID-Related

- COVID-related absence:
 - School directs student to stay home: individual student, classroom, or building
 - Parent-directed COVID-related absence accepted by the school
- Q: Our school doesn't collect COVID-related absence data
- A: Do the best you can to determine if adequate information is present to verify COVID was reason for absence

尽 SY2022-2023 P-EBT Data Upload

- Data requirements remain the same from SY21-22 benefits
- Compile and upload data by month
 - Do not need to upload file for months where no student qualified
- SY22-23 P-EBT File Upload Instructions

Fall Semester (August 2022-December 2022)	May 15, 2023	May 22, 2023	June 22, 2023
Spring Semester (January 2023 – May 2023)	June 30, 2023	July 10, 2023	August 15, 2023

尽 SY2022-2023 P-EBT Homeschool/Remote

- Eligible Students *NEW*
 - Must have disenrolled from/ become remote student at NSLPparticipating schools due to concerns about COVID-19 at some point between the start of the pandemic (January 27, 2020) through the current 2022-2023 school year
- Household will be responsible for contacting DHHS to initiate the application process
 - Tentative Application Release Date: April 17, 2023
 - Tentative Application Deadline: May 26, 2023
- The NDE will confirm disenrollment dates with school districts

iii Summer 2023 P-EBT Benefits

- Qualification Requirements
 - Qualify for Free or Reduced-priced meals by the submission of an income application or direct certification during SY22-23;

AND

- 2. Be enrolled at your school district on the last day of SY22-23.
- \$120 benefit amount issued to each qualifying student

iii Future of Summer P-EBT

- Summer P-EBT benefits to become a permanent, nationwide program starting in Summer 2024
- Eligibility requirements and issuance amounts are unknown
