ADVISER 2022-2023 Status

- “End of Year (Locked)” reports now available in ADVISER Validation
- The 2022-2023 Follow Up Collection is now occurring, through 10/2/2023
 - Includes Course, Graduation, and SPED data
 - Districts should not do anything to damage their existing 22-23
 - Some Powerschool districts have removed their graduation records, everyone please review your Completer and GCAT validation reports

ADVISER 2023-2024 Updates

- The new 22-23 and 23-24 ADVISER servers are receiving data, and the new ADVISER Validation website is running
- Some errors were moved to their own “Prior School Year” category
 - After you start publishing 23-24 data, focus on these errors in case it reveals issues with your 22-23 student enrollments
 - Can still fix 22-23 data in Follow Up collection until 10/2
 - **Fix happening in next day:** these errors in 23-24 should look back at *live* 22-23 data right now (after 10/2 they will be switched to looking at 22-23 *locked* data)
- NDE is nearly finished certification testing with vendors, see [2023-2024 ADVISER Vendor Certification – Nebraska Department of Education](#)



ADVISER Upgrade Results

- Deployment proceeded basically as planned on 9/1
 - Portal issues with certificates on 9/5 unrelated to ADVISER
- During week of 9/5 – 9/9 overnight data loads were set up and fixes made in Validation site as they were discovered
 - Some reports that wouldn't load in 22-23 have been fixed
 - 22-23 Cohort and Course data are building overnight now
 - Issue with how long it took Validation site to open from portal is fixed as of Friday
 - Fixed issue with missing student IDs in 23-24 as of Wednesday
- NDE still needs to make some corrections in 23-24 reports/errors to accommodate the updated SPED/Discipline data elements this year

November 22, 2023	All student data released on NEP Snapshot (public) site.
February 1, 2024	Financial data released to NEP Snapshot (public) site.
June 1, 2024	District SPED Performance Report Part B released to NEP Snapshot (public) site.
