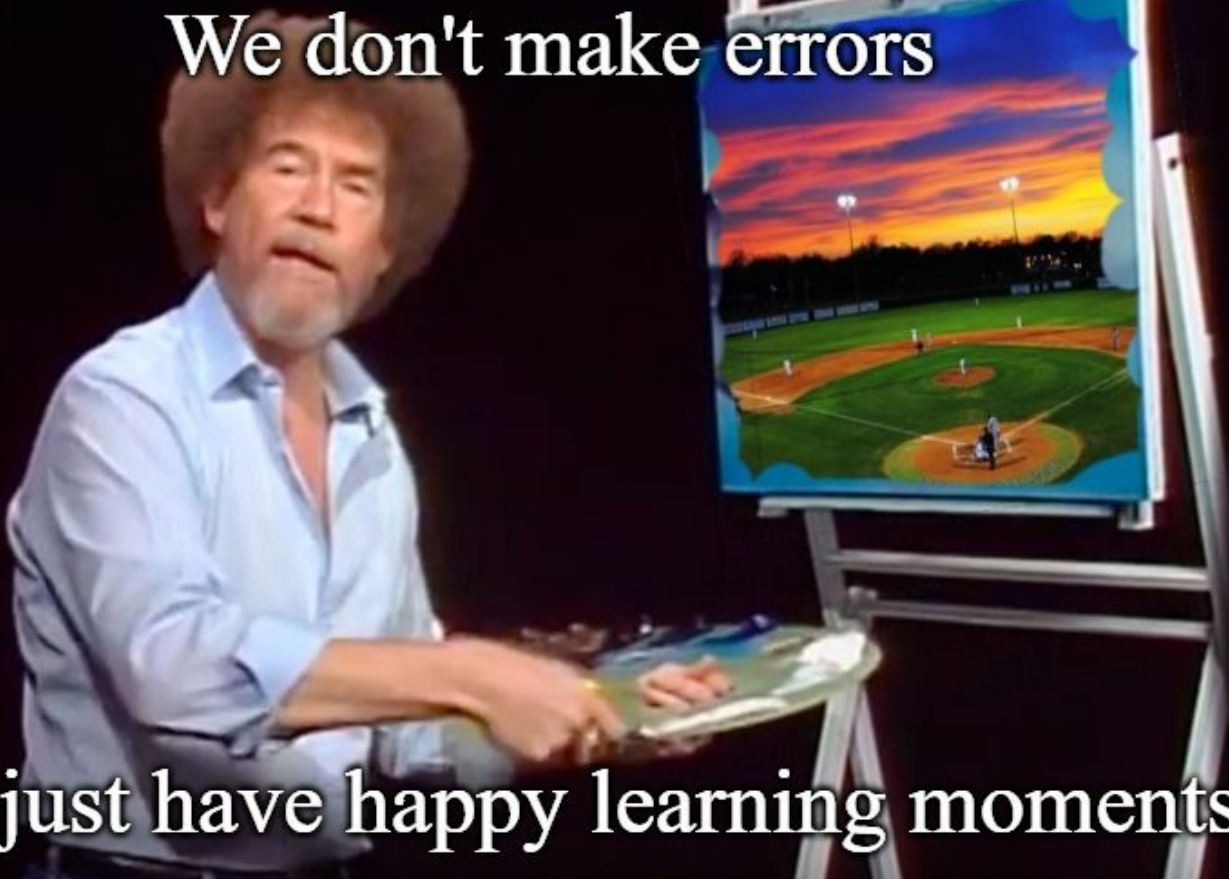

Collection & Audit Window Dates

- **October 1st** (Federal Child Count Date)
- **October 15th** Fall Collection is due (as of 10/1)
 - includes Individuals with Disabilities Education Act (IDEA) Annual Child Count
- **October 16th - 31st** Fall Audit Window
 - Review and Clear your ADVISER Validation Errors prior to the data being locked on **Oct 31st**
